WHO IS THE ACA?

ACA is a professional society of accredited angel investors who make up the world's most prolific early-stage investment class. The association is the largest professional development organization for angel investors in the world deploying more than \$650 million in early stage capital each year. ACA provides an insider perspective that can help you make smart investment decisions.

- **Prolific:** Angel investors support up to 90% of outside equity raised by startups (after friends and family)
- **Jobs:** over a 25-year period, firms younger than five years accounted for all of the net new jobs in the U.S.
- **Economic growth:** research shows that the largest growth comes from high-growth, innovative startups, the kind angels fund
